

ENBYouthCo-nnect: English National Ballets young collective. Application Guidelines & Information

Please find below further information about ENBYouthCo-nnect and the application process for prospective young dancers to join us in September 2023.

ENBYOUTHCO-NNECT – Overview

ENBYouthCo-nnect is a one-year programme where young dancers work with ENBYouthCo-nnect Creative Director, Jo Meredith, and a team of dynamic and highly experienced professional artists. Designed for young dancers aged 13 -16 years the programme provides a unique training experience in ballet and contemporary dance technique, introducing choreographic skills and working towards opportunities for live performance.

For those with a minimum of 1 years dance experience, it is recommended to those looking for additional opportunities to enhance their choreographic and performance skills, to support future prospective applications to audition for programmes such as ENBYouthCo.

Age guidelines: ENBYouthCo-nnect prioritises dancers aged 13 - 16 years, however if you are above or below the age range with a minimum 1 year dance experience please contact us directly and if we have the capacity we would love to welcome you.

ENBYOUTHCO-NNECT – Annual Cohort

The annual programme takes place at ENBs home, Mulryan Centre for Dance, on Fridays at 6:15 – 7:45pm.

Dancers will work with the Creative Director and collaborate with professional Dance Artists, Choreographers, and Dancers of ENBYouthCo, to broaden their knowledge of dance technique and choreographic skills by taking part in supplementary classes and creative sessions; building confidence to perform alongside ENBYouthCo at ENB's annual *RePlay* platform in March 2024 – an evening of dance co-curated with young people.

APPLICATION

Dancers who would like to join ENBYouthCo-nnect must complete the application form here.

- This is an open application process therefore once submitted you will be notified within 7 working days if you have been successful. Once the programme is full, we will not take your application any further and you will be placed on a waitlist.
- Latest opportunity to apply is by Monday 25 September 2023, 10am.

FEES

The Annual Membership Fee is £225.

ENBYouthCo-nnect is a 1-year programme and the fee covers all activity listed above under core dates September 2023 – July 2024.

Instalment are available to all dancers, which is broken down into:

- 1. £75 upon registration
- 2. £75 on or by 30 November 2023
- 3. ± 75 on or by 31 March 2024

BURSERIES – Further Information

Bursaries are means-tested, with up to 100% of the annual membership fee and up to 100% of the summer intensive fee available for three young dancers.

Subject to availability and offer of full place bursaries, up to 25% of fees may be available to support those who live outside of Zone 6 (London).

By the offer of membership, you will have already shown a strong aptitude for dance and the potential and commitment. All bursary applications will be assessed using the framework below, bursary application information will be sent to final Company members when they are offered a place in the company.

Do I qualify to apply for up to 100% of the Membership Fees?

This is available for those households whose total income is less than £31,170 in the tax year ending 5 April 2024, *and/or* for young dancers who are Pupil Premium or Pupil Premium Plus.

Do I qualify to apply for up to 25% of the Membership Fees to support travel?

If you live outside of Zone 6 you will be able to apply for up to 25% of your Membership fees to be reduced.

How do I apply?

Bursary application information will be sent to prospective ENBYouthCo-nnect members when they are offered a place. You will be asked for a statement of proof and a supporting statement which will determine the percentage of funding.

How many are available?

One 100% Membership Fees are available, and two up to 100% Membership Fees are available to apply for. The amount of travel bursaries is subject to availability.
